### 4.1 Strategic Plan 2025

- NCEA Level 1 Religious studies course is compulsory

- All assessment completed for this term and are looking at planning for next term. Finding that strategies and planning used last year need changing as they are not as effective this year.

#### Strategic Goal: Community

- Attendance is a big focus. Restructure in admin to better address this.
  - Rolls done by 9.30. Checked by attendance officer at 10.30 and notifications sent after this.
  - Rolls for primary done for primary twice a day with attendance on half days.
  - Rolls for secondary done before each lesson.
  - Attendance West can work with other government agencies to help resolve attendance issues.
- MoE curriculum visits are always positive and provide good support.
- NCEA level 1 is new and expectations are a lot higher than previous NCEA level 1.
- On track to be able to deliver curriculum NCEA level 2 next year.
- Manada Mataji is principles nominee for the curriculum development and is ensuring the teachers are part of the relevant associations and are meeting the new curriculum requirements.
- Good engagement by the majority of parents on new high school curriculum.
- Standardised test results are provided to parents in their child's school report.
- High School looking to implement disciplinary actions for those not completing their homework.
